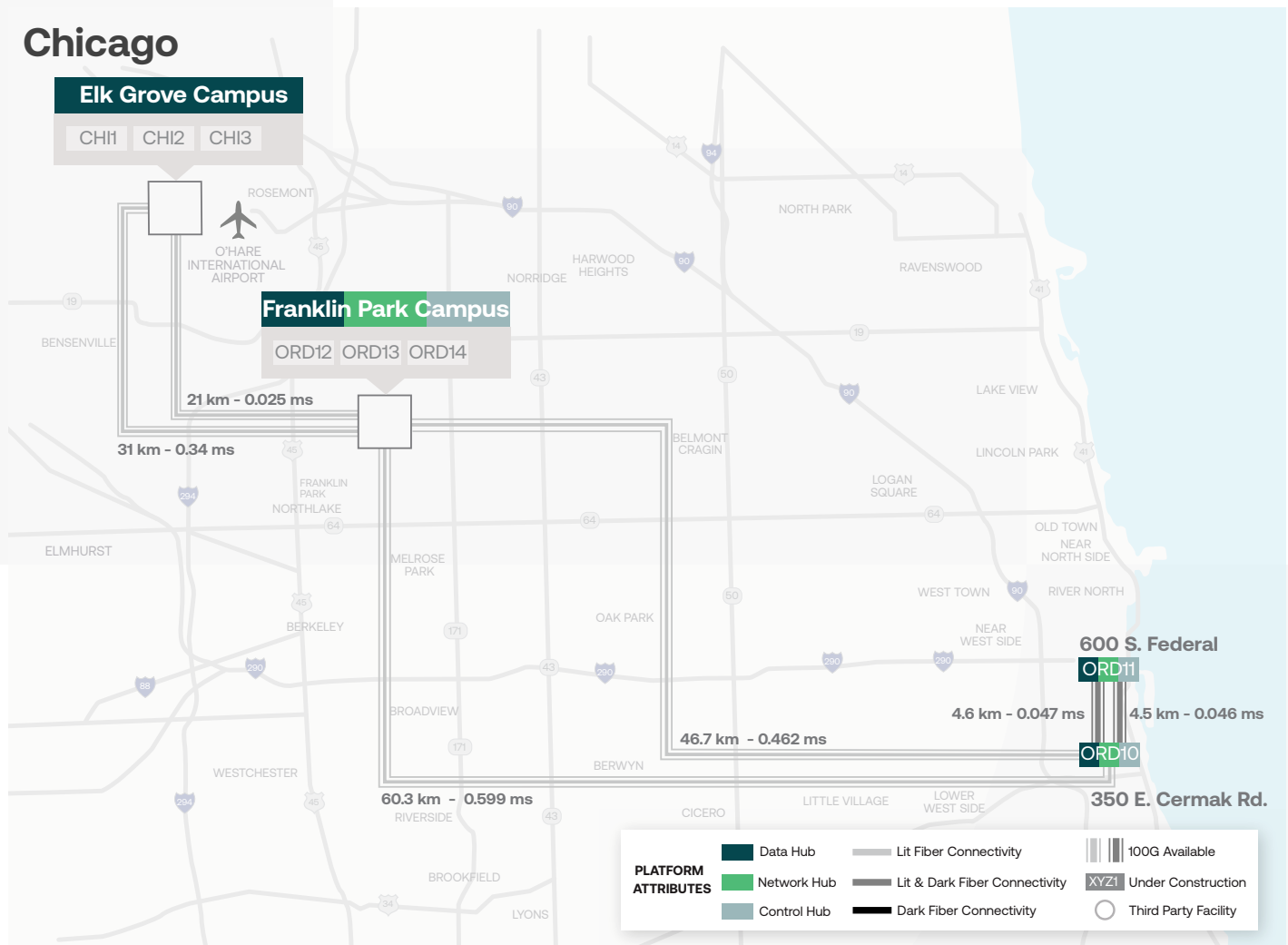




# Why 350 East Cermak Road?
