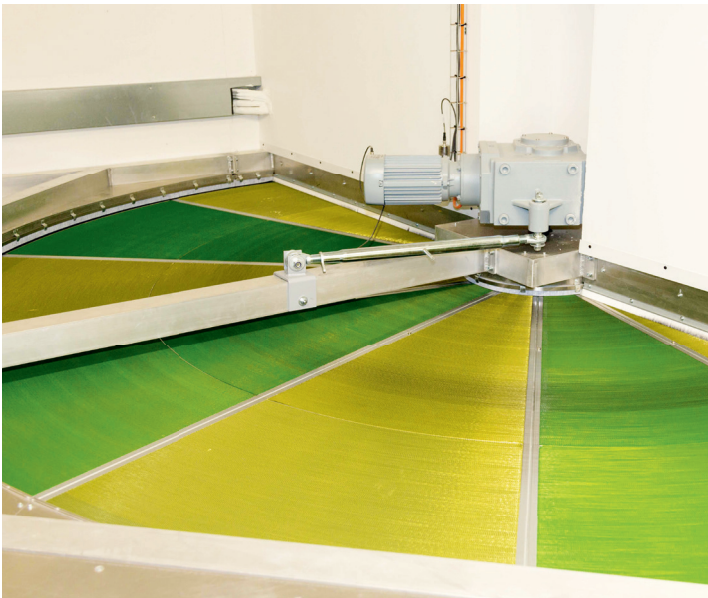

Location and general building properties

- ◆ Goethering 29, D-63067 Offenbach am Main (Campus of energy provider)
- ◆ Risk analysis: No special risks

IT rooms and capacity

- ◆ IT area 4,200 sq m, over three levels with 2 IT rooms of 700 sq m each
- ◆ Standard rack dimensions: 800 mm x 1,000 mm x 52 U (other dimensions on request)
- ◆ Number of standard racks per IT room (without cages): 357, cages optional
- ◆ Consistent cold-aisle containment
- ◆ IT load / cooling capacity per IT room: 1 MW
- ◆ Hot spots up to 40 kW per rack for high performance computing
- ◆ PUE ≤ 1.3 (guaranteed)
- ◆ Redundancies: Power 2N (Piller IP bus, ring), Cooling N+1 (KyotoCooling)

SLA, contract rights and data protection

- ◆ SLA availability: 100 %
- ◆ Temperature and relative humidity: 18 °C – 27 °C @ 20 – 80 %, individual climate conditions on demand in dedicated suites
